



Organizational Development

- GBD approved by 76% of property owners & formally organized as a 501(c)(3)
 ✓ Received City assessment disbursements, totaling \$500,000 in FY 1.
- Set-up for business and banking
 - ✓ Became a registered City vendor, hired legal representation, opened bank accounts.
- Elected and empaneled a Board of Directors
 - ✓ The 13-member board represents property owners, renters and green space advocates from Dogpatch & Northwest Potrero Hill.
- Hired an Executive Director
 - ✓ Julie Christensen on board in June, 2016.



Services, Plans & Programs

Stepped-up community outreach & engagement

- ✓ Set up a new website. Produced e-newsletters, advertised in neighborhood publications and sponsored neighborhood events.
- Planned & executed the *Jumpstart Maintenance Program*
 - ✓ Coordinated & leveraged investments by working with RPD in Esprit Park.
 - ✓ Completed improvement projects in 8 parks: path and drainage additions, upgrades and repair; pruning and planting; trash and graffiti removal.
- Added Angel Alley to the group of (now) 12 managed green spaces
- Managed graffiti, trash and dangerous homeless encampments
- Hired key vendors for on-going janitorial and landscape maintenance
 - ✓ Includes sidewalk and park cleaning, graffiti abatement, dog waste collection, watering, weeding and pruning, and debris removal for 12 parks and the benefit district at large.




✓ Develop lighting design standards and work with property owners, local, and regional entities to improve and expand lighting in parks and streets.
